

1 Chairs Welcome

The chair, Steffan Chambers welcomed the attendees to this meeting.

2 Apologies

Chris Tibbetts, Jo Tibbets, Matt Coulson send their apologies.

3 Field Condition Update

Steffan Chambers requested that he like would raise an urgent matter. There is a lease on the football field for £1 per year payable every five years. The lease payment has not been made for the last 2 years according to CCG, however, it's not clear whom is responsible for the field lease. CCG have offered a new lease at £52 per year. It's possible that the lease could have last been paid by the consolidated Llanbedr, Dyffryn Ardudwy & Talybont football club as the timing would be approx. correct. There is mention in the minutes and documentation from Dyffryn & Talybont FC about the lease on the field but not the final solution, the documents only go as far as end of 2008. The land itself is recreational land and was given to the community nearly 40 years ago, however, the then Sports Association were private citizens and they were not permitted to own the lease, it must be by an organization, preferably the local or community councils.

Eryl Jones-Williams joined the meeting to provide an update on the leasing of the field, Eryl has had several email discussions with CCG which were handed over to Steffan Chambers to investigate in more detail. Josh Bowater advised that he will check back with the people involved in the Llanbedr, Dyffryn Ardudwy & Talybont football club before it closed down. Documents after 2008, would ideally need to be located along with any financial data which support the leasing arrangements for the football field. Critical information which is required are;

CCG payment for existing arrangements

2. Invoice / correspondence address

The club all agreed that it would like the Community Council to hold the lease if possible.

Steffan Chambers to contact RJ Jones to get details of what land is for sale/rent next to the football field.

Steffan Chambers to request details from CCG of the tittle deeds and whom has been paying the lease on the football field.

The goal posts are nearly 20 years old and need inspecting, there was a discussion around how to remove/replace them, it was decided to contact the FAW.

Steffan Chambers to contact Alan Faulks concerning the regulations around siting the goal posts.
